**Anderson, Ryan, MD** – License No. MD2005-0470 – Issued a letter of reprimand based on abandonment of patient, failure to maintain accurate and adequate medical records and interaction with others that could adversely impact patient care. (April 2016)

**Ayon, Dennis, MD** – Applicant - Stipulation and Order for Withdrawal of Initial Application. Per Stipulation, Dr. Ayon withdrew his application for licensure in New Mexico while under investigation. (May 2016)

**Dharma, Kalamani, MD** – Applicant - Stipulation and Order for Withdrawal of Initial Application. Per Stipulation, Dr. Dharma withdrew her application for licensure in New Mexico while under investigation. (April 2016)

**Diaz, Pedro, MD** - Applicant – Order granting motion for costs. Dr. Diaz must pay to the Board its costs incurred totaling \$1,544.63 within 90 days. (May 2016)

**Fernandez, Jose, MD** – License No. MD2008-0806 – Notice of Contemplated Action was issued based on fraud or misrepresentation, failure to report to the Board any adverse action taken against the licensee by a law enforcement agency and conduct unbecoming in a person licensed to practice. (May 2016)

Flores, John, MD – License No. 2002-0142 – Order of Immediate Suspension due to imminent danger to the public. Simultaneously, a Notice of Contemplated Action was issued based on, gross negligence in the practice of a licensee; manifest incapacity or incompetence to practice as a licensee; prescribing, administering or dispensing of a narcotic, stimulant or hypnotic drugs for other than therapeutic purposes; conduct likely to harm the public; repeated similar negligent acts; injudicious prescribing; conduct unbecoming in a person licensed to practice or detrimental to the best interest of the public and improper management of medical records. **Garbrecht**, **Erika**, **MD** – License No. RS2013-0494 - Stipulation of Licensure mandating that physician abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract with NM Monitored Treatment Program. This is not considered a restriction on the license. (May 2016)

**Hansen, Terry, MD** – License No. MD2015-0101 - Issued a letter of reprimand based on misrepresenting material facts in initial and renewal applications for license to practice medicine and engaging in a pattern of dishonesty. (April 2016)

**Irizarry**, **Debra**, **MD** – License No. 96-77 - Order of Release from Stipulation. Licensee has a full and unrestricted license. (May 2016)

**Lietzke**, **Christiana**, **MD** – License No. MD2014-0021 – Decision and Order to defer final action until Dr. Lietzke completes a neuropsychological evaluation within 90 days of the Order. The order is based on the number of States involved in adverse and disciplinary actions taken against Dr. Lietzke, the nature of the stipulations entered into as a consequence of those adverse actions and Dr. Lietzke's unresponsiveness and failure to report those actions. **Martin, Richard, MD** – Applicant - Stipulation and Order for Withdrawal of Initial Application. Per Stipulation, Dr. Martin withdrew his application for licensure in New Mexico while under investigation. (April 2016)

**Miller, Clyde, MD** – License No. MD2007-0136 - Order granting motion for costs. Dr. Miller must pay to the Board its costs incurred totaling \$3,412.50 within 90 days. (May 2016)

**Pendrak, Robert, MD** – License No. MD2005-0209 – Stipulation of Licensure and Order. The stipulation places limitations on Dr. Pendrak's license to practice medicine in New Mexico. He must limit his practice to a general urgent care or family practice setting and limit his surgical privileges to simple procedures completed in an out-patient office setting, such as incision and drainage of abscesses and removal of simple skin lesions. This Stipulation is a non-disciplinary action. This action is based on the summary suspension of Dr. Pendrak's medical privileges and medical staff membership at Cibola General Hospital. (April 2016)

**Pistone, Daniel, MD** – Applicant - Stipulation of Licensure mandating that physician enter into a contract with NM Monitored Treatment Program for monitoring of his continued mental health treatment and shall comply fully with the recommendations, terms and conditions required. This is not considered a restriction on the license. (May 2016)

**Sehbai, Aasim Shaheen, MD** – Applicant - Stipulation and Order for Withdrawal of Initial Application. Per Stipulation, Dr. Sehbai withdrew his application for licensure in New Mexico while under investigation. (April 2016)

**Thyagaraj**, **Sujan**, **MD** – License No. MD2010-0267 – Stipulation and order for continued suspension of license and for stay of administrative proceedings pending resolution of criminal proceedings. (May 2016)

**Woody, Robert, MD** – License No. 95-162 – Stipulation and Order for continued suspension of license and stay of administrative proceedings pending resolution of criminal proceedings. (May 2016)
