MESSAGE FROM THE EXECUTIVE DIRECTOR

The NM Medical Board would like to announce two new licensed professions.

Genetic Counselors

SB 415 providing licensing requirements for Genetic Counselors was enacted at the end of the 2008 Legislative Session. Article 6A, the Genetic Counseling Act was added to the Medical Practice Act. All Genetic Counselors practicing in New Mexico will need to be licensed effective July 1, 2009. Licensure and practice requirements are detailed in Title 16, Chapter 10, Part 21 of the NM Medical Board regulations and is open for public comments. 16.10.21 may be viewed on the Board's web site at www.nmmb.state.nm.us.

Polysomnographic Technologists

SB 269 providing licensing requirements for Polysomnographic Technologists and creating a Polysomnography Practice Advisory Committee was enacted at the end of the 2008 Legislative Session. Article 6B, the Polysomnography Practice Act was added to the Medical Practice Act. All Polysomnographic Technologists practicing in New Mexico will need to be licensed effective July 1, 2010. Regulations for this profession will be drafted in the next few months.

PROPOSED RULE REVISIONS PUBLIC RULE HEARING NOVEMBER 14, 2008

The Board is considering rule revisions to the following regulations as summarized below.

If you are unable to attend the rule hearing, please submit written comments by November 10, 2008. For a full copy of the proposed revisions, visit the Board's web site at www.nmmb.state.nm.us or call (505) 476-7220.

16.10.5 Disciplinary Power of the Board

Revise to include Genetic Counselors and Polysomnographic Technologists.

Revise to add Section 16 to define summary suspension as it relates to the passage of HB 177 that authorizes the Board to summarily suspend a license without a hearing if the licensee poses a clear and immediate danger to the public health and safety.

<u>16.10.6 Complaint Procedure & Institution of Disciplinary Action</u>

Revise to include Genetic Counselors and Polysomnographic Technologists.

16.10.7 License Expiration, Renewal, and Reinstatement Revise to clarify license expiration dates, ability to practice between the license expiration date and the suspension date, as well as, clarify the reinstatement process.

16.1<u>0.9 Fees</u>

Revise to add Section 11 for Genetic Counselor fees.

<u>16.10.15 Physician Assistants: Licensure & Practice Requirements</u>

Revise Section 8 to further clarify and define qualifications for licensure as a physician assistant.

16.10.16 Administering, Prescribing & Distribution of Medication

Revise Part 16 to define physician-or physician assistantpatient relationship.

Proposed Rule Hearing Revisions Continued

16.10.17 Management of Medical Records

Revise to include electronic medical records, and revise subsections regarding closing, selling, relocating or leaving a practice.

16.10.21 Genetic Counselors: Licensure & Practice Requirements

Part 21 is a new regulation that details the licensing requirements for Genetic Counselors.

NOTE: All proposed rule revisions are posted 30 days prior to a rule hearing on the Board's web site and we encourage you to periodically check the web site for the most timely notification. WHAT HAPPENS WHEN A COMPLAINT IS FILED AGAINST AN MD, PA, OR AA? By Paul Kovnat, M.D., Board Chair

Anyone can file a written complaint alleging a violation of the NM Medical Practice Act against a physician (MD, physician assistant (PA) or anesthesiologist assistant (AA) licensed in New Mexico. The New Mexico Medical Board (Board) investigates all complaints over which it has jurisdiction.

The Board investigative staff opens a case and conducts a preliminary investigation. As part of the preliminary investigation, the MD. PA, or AA named in the complaint is usually notified that a complaint has been filed and invited to provide a written response. The investigator may also request medical records, exam records and other supporting documentation. If necessary, the Board may use its subpoena power to obtain the necessary records. NOTE: All records obtained for use in an investigation are *confidential* pursuant to Section 61-6-34 of the Medical Practice Act and not available to the public or the complainant unless the matter goes to a formal hearing.

The next step in the process is for the investigator to present the case to a Complaint Committee, usually consisting of 2 board members. The committee members review all the information and prepare a recommendation to the entire 9-member Board. At this time, the case is referred to by case number and only the members of the Complaint Committee know the name of the complainant and the MD, PA, or AA. Members of the complaint committee abstain from the vote of the entire Board.

If the Board votes to close the case, the complainant and the MD, PA, or AA are so notified. All communications relating to the closed case remain confidential and are not public records.

If the Board votes to issue a Notice of Contemplated Action (NCA) or take other formal disciplinary action, the licensee is notified of the allegations and of their rights to an attorney, a public hearing to call witnesses on his or her behalf, and to cross-examine the complain-

After the hearing, the Board votes on whether or not the licensee has violated the Medical Practice Act. If a violation has occurred, the Board may discipline the licensee, including revoking the license to practice. Within the last 3 years, the Board has investigated 596 complaints, the great majority of which were closed. Twenty-four (24) licenses were restricted and two (2) licenses were revoked.




